PRESIDENT'S MESSAGE

This year has been a breakout year for State Schools' Relief with the decision by the Andrews Government to provide \$15.6 million over the next four years to enable us to greatly increase the scope and quantity of support we provide to disadvantaged children attending state schools.

State Schools' Relief's journey of change and transition will be greatly enhanced as we continue to develop our strategic planning and management capacity to deliver services at greater levels to a much larger number of students.

In this context it is also critical to ensure that we continue to maximise our fundraising and work actively with our schools, sponsors and individual contributors to make sure that fundraising continues to be a core component of our activity.

As part of the boards ongoing change processes this year major changes were made to our service delivery model. The co-payment model has been reduced while direct delivery of clothes and shoes to students via their schools has been substantially enhanced. This has generally meant that we have been able to operate on a lower cost per unit basis, our service has been more timely and the amount of outstanding co-payments substantially reduced.

Our planning has also involved the creation of our own clothing label Student's Choice and the imminent relocation to new headquarters in Dandenong to an office/warehouse complex.

All our sub committees have continued to work actively, particularly Audit and Risk which under the leadership of Rommie Redlich has developed a comprehensive and accountable risk management system for State Schools' Relief.

The Marketing sub committee is chaired by Maria Shearn and has the task of ensuring that fundraising, particularly from schools, continues to remain a priority. Our corporate fundraising has been particularly successful mainly through our involvement with the City of Dandenong's golf day.

Christine Stewart and Ralph Francione continued to provide the impetus for organisational modernisation through their work on the Rules Committee aimed at keeping our rules and governance processes up to date.

The Sustainability sub committee has also been created to consider our future planning.

The State Schools' Relief executive meets monthly and is responsible for the governance, strategic decision making and financial accountability of the organisations between Board meetings.

Last year State Schools' Relief appointed a new CEO, Stephen Iles, and since his appointment he has been instrumental in driving the new directions of State Schools' Relief while maintaining the focus on our core business. Stephen has worked tirelessly to ensure that our systems and processes are continually improving. Stephen has also been a great advocate for the work of State Schools' Relief and has put us on the map as one of Victorias leading organisations working in social justice for disadvantaged people. Stephen is very well supported by the staff of State Schools' Relief and I thank each and every one for their hard work and dedication. Specific thanks are due to Val Marshall and Pam Williams for their work with schools and students. Both are highly regarded for their customer service and the care and attention they give to their clients.

The State Schools' Relief Board this year welcomed on Robyn Wilson representing the Association of Business Managers, Judi Benney representing the Victorian Association of Secondary Principals and Dean Mann from the Department of Education, while Tony Collins and Keri Langes resigned and Kate Fenby is on long term leave from the board. The Board is now at full strength and is well positioned to lead the organisation to meet future growth and challenges. I thank all my fellow Board members for their support and guidance over the past 12 months.

State Schools' Relief cannot do the work it does without the support of our sponsors. Our ongoing support from the Department of Education is irreplaceable whist support from our major sponsors, The Australian Schools Canteen Association, bankmecu, Victorian Teachers Mutual Bank and The Australian Education Union effectively facilitates our efforts to provide support to a large number of students in Victorian state schools.

On behalf of the Board I thank all donors, large and small, to the SSR cause.

The future for State Schools' Relief is bright. In an environment of growing demand we have many challenges and changes to manage. However because of our systems and procedures and the quality of our Board and staff we are very well placed to successfully continue to grow and develop State Schools' Relief into its 86th year and beyond.

CEO MESSAGE

2015 has been a year of tremendous change, achievement and growth for State Schools' Relief. Two major changes have transformed the organisation, significant revenue growth and dramatic cost control in the face of major external challenges. These challenges arise from the elimination of the Education Maintenance Allowance previously paid to low income parents as well as the continuing job losses in Victoria's manufacturing sector.

The \$15.6m commitment from the Victorian Government will have a transformative effect on the scale and impact of our efforts to tackle disadvantage and drive participation in Victoria's government schools.

State Schools' Relief has successfully trialled and implemented a new strategy of direct fulfilment of clothing and footwear under our new Student's Choice label that has collapsed the cost of rapid expansion. In 2015 a 27 percent increase in applications resulted in 1 percent increase in cost. This compares well with 2014 where 18 percent growth in applications resulted in a 60 percent cost increase.

I am aware of the tremendous support enjoyed by State Schools' Relief from a wide range of essential stakeholders that have enabled these wholesale changes. Without their continued interest and commitment to tackling disadvantage, the work of State Schools' Relief would simply not be possible. I would like to formally acknowledge this commitment.

School communities

School communities continue to drive the success of State Schools'
Relief with fundraising for disadvantaged students in schools is of
particular note. Established by principals and teachers, State Schools'
Relief continues to be sustained by Victorian educators.

Staff and volunteers

I am especially thankful for the support and dedication of State Schools' Relief staff, in particular Val Marshall and Pam Williams. We have welcomed Brian Macharia during the year to lead our finance team. They have supported the organisation's work during a period of organisational change with professionalism. The implementation of the online application database has been a major achievement. A new workforce planning model that formally incorporates the tireless efforts of committed volunteers has been essential to our success in constraining costs. Thank you.

Board

The board has given me great support. I am particularly appreciative of the support and work of the President, Barry Smith. His committed leadership has ensured that strong governance and disciplined risk based decision making have guided the organisation through great changes. I thank each member for their work in the committees of the board. It is essential to our ongoing success.

Partners

State Schools' Relief relies on a committed group of sponsors and donors to maintain our work. The support of the Australian Education Union, Victorian Principals' Association and Victorian Association of State Secondary Principals all are essential in the work of State Schools' Relief. The Department of Education and Training (DET) and bankmecu are tremendous sponsors. While Australian School Canteens Association and Victorian Teachers Mutual Bank are fantastic impact donors.

Financial Performance

I'm pleased to provide the following financial highlights:

- Operating profit amounted to \$15,455, an increase of 19% compared with the last financial year.
- Total expenses amounted to \$119,830, a reduction of 45% compared with last financial year
- Cash at bank \$1.03m, up 4% compared to last financial year
- Total assets increased 5% compared with last financial year to \$1,22m
- Total equity \$1.08m, an increase of 1% compared with last financial year

Challenges


The successful approach in dealing with the removal of the Education Maintenance Allowance (EMA) is essential in dealing with the elimination of the Australian Government's *School Kids Bonus*. This payment is made to low income households with children enrolled at school. The impact of its removal will be even greater and is scheduled to cease in July 2016.

State Schools' Relief expects that many of these children will be reliant on State Schools' Relief in 2016 for clothing and footwear as a result.





THE CHALLENGE

Increased demand:

Historically State Schools' Relief has provided shoes and uniforms for around 10,000 students each year. This financial year recorded a 27% increase in applications to 12,232 with 70% of these being submitted in 2015. A proportion of this increase has been attributed to the discontinued Education Maintenance Allowance (EMA) in 2015. 25% of families with children attending State Schools' received the EMA previously, corresponding to around 160,000 children in 2015. The partial replacement of this payment is the Victorian State Government grant State Schools' Relief secured for \$15.6m over 4 years, representing a benefit of \$20 per child. The average cost of each application to State Schools' Relief was \$120. Additionally, the School Kid's bonus of \$422 for Primary School students and \$842 for Secondary students will be discontinued in 2016, consequently a further increase in applications is expected.

OUR RESPONSE

Reducing the cost of growth:

State Schools' Relief recorded a 42% increase in costs of Student's Choice items, and 9% decrease in branded items. This corresponds to a total increase in cost of only 1% while providing our service to 25% more students. Providing an increasing proportion of Student's Choice clothing is a long term strategy for State Schools' Relief in order to continue to provide support to an increasing number of students.

Future income commitment:

State Schools' Relief has successfully facilitated a commitment from the Victorian Government of \$15.6m over the next 4 years. The will have a transformative effect on the scale and impact of our efforts.

Enhance recognition and engagement:

- Within schools
- External stakeholders

State Schools' Relief work with a range of stakeholders to provide a high quality service. Our staff liaise with State Schools across Victoria to ensure that our services are recognised and utilised by those in need. SSR also work with external stakeholders to continue providing high quality uniforms at the lowest possible cost to help students remain in school.

Utilise Student's Choice items:

One successful method of decreasing the average cost per child has been by working closely with Schools to provide our Student's Choice label uniforms and shoes where possible. High quality clothing is provided which closely resembles the branded items largely used by other students.

Increase Volunteers and in-kind support:

State Schools' Relief are proud to have a variety of volunteers assisting how possess a range of skills ranging from packing and sending packages to schools to accounting expertise. Through the financial year State Schools' Relief acquired the equivalent of 87 days unpaid voluntary work. Utilising the standard hourly rate used for volunteers of \$27.36 this equates to \$19,000 in kind assistance.

HOW WE CREATE VALUE

Creating a Social Return on Investment:

State Schools' Relief commissioned Monash Business School to complete a report articulating the 'Social Return on Investment'. The report concluded that for every \$1 provided to State Schools' Relief, a value of \$6.78 was returned to the community. This figure is a conservative estimate given the difficult nature of qualifying such impacts. In summarising the methodology, the objective of Secondary School retention was the most direct method of calculation. This discounts the benefit derived from Primary School students supported which may have assisted attendance to this point. The following impacts were highlighted:

- Increase in salary potential
- Increase in taxes paid
- Reduced social welfare reliance
- Social and economic benefits of employment
- Productivity contribution
- Reduced crime rate

Reducing costs to Victorian families:

Offering Student's Choice - State Schools' Relief trial schools 75% more students with 115% more clothing at only 13% more cost. Second hand purchasing smartphone app — clk2sell is similar to eBay for buying and selling children's school uniforms. The pilot was launched September 2013, and in the financial year 2014-15 users saved an average 50-70% compared with retail price.

Creating a trusted, reliable, responsive service:

State Schools' Relief have a history of capacity, efficiency and experience to service demand. Currently, service level agreements of 90% delivery within 3 business days are being exceeded.

Continuing to help students remain at school by expanding our services:

School uniforms and shoes are crucial to school retention. After working with State Schools' Relief stakeholders other opportunities have been identified to continue this vision through pilot projects:

- Eye testing In partnership with OPSM State Schools' Relief have engaged with 250 schools to ensure students have access to glasses where required.
- Books and stationery As stated in the State Government media release advising of the \$15.6 million grant to State Schools' Relief, services will be expanding to provide books and stationery.
- Work boots This pilot has been running since April 2015, to provide VCAL students with work boots so that they can participate in their studies. From April 2015 to June 2015 30 pairs of boots were provided to the value of \$600.
- Calculators Scientific calculators are utilised by Year 11 and 12 students. They are a significant cost to families of the student retailing over \$200.

CAPTURING THE VOICE OF OUR STAKEHOLDERS

SCHOOL DONATIONS PER CHILD

We would like to say thank you to the Schools, Junior School councils, teachers, Principals and Student Representative Council Committees for the fundraising support for the thousands of Victorian children unable to afford basic necessities such as school uniforms and footwear. This financial year 251 schools donated a total of \$202.258.

Almost 15% of State Schools across Victoria donate to State Schools' Relief. This comes in many forms, from out of School Uniform Days, Schools asking parents to round up their school fees to the amazing efforts of McKinnon Secondary College and their 24 Hour Relay.

This financial year, 20% of schools donating to State Schools' Relief donated \$2 or more per child, corresponding to more than 50% of the total amount donated.

FINANCIAL PERFORMANCE

This financial report is an extract from the audited financial statements of State Schools' Relief.

The financial year 2014-15 was very busy for State Schools' Relief. The reduction in financial assistance for many families with children studying in Victorian State Schools has resulted in an increase in applications. Increasing costs of branded clothing and footwear continues to be a challenge, which is being tackled by various methods including providing an increasing number of Student's Choice items to students.

Financial highlights:

- Operating profit amounted to \$15,455, an increase of 19% compared with the previous financial year.
- Total expenses amounted to \$119,830, a reduction of 45% compared with the previous financial year
- Cash at bank \$1.03m, up 4% compared to previous financial year
- Total assets increased 5% compared with previous financial year to \$1.22m
- Total equity \$1.08m, an increase of 1% compared with previous financial year
