SSR

State Schools' Relief is a not for profit charity that supports the needs of disadvantaged government school students by assisting them with new school uniforms, footwear and educational resources at a time of vulnerability.

Providing new shoes and uniforms to a child experiencing extreme disadvantage provides considerable benefit. Our simple and practical service ensures that students in Victoria can attend school in warmth and comfort with a greater sense of belonging and self-esteem; enhancing their educational prospects and opportunities for connecting with their school community.

Our History

State Schools' Relief was founded in 1930 during the Great Depression, by Anton Vroland a Head Teacher from Elsternwick State School.

On June 12 1930, Anton Vroland organised a meeting with fellow teachers and principals who were concerned about the students living in the barges along the Yarra and huts around the Dudley Flat tip. At the conclusion of this meeting, the State Schools' Relief Committee was formed to undertake any relief possible to Victorian students.

The problem of poverty, neglect, family illness, abuse, homelessness and natural disasters continue to pose an affect for too many families.

State Schools' Relief is unique; no other Australian State has a similar organisation. Our service promotes each child's dignity because the service is run anonymously through the schools.

It would be almost impossible to find a State School, no matter how prosperous, that has not had at least one student who has received assistance from us in the past 86 years.

The importance of our work and the thousands of students we help each year ensures that they feel included and valued. It provides everyone, regardless of background, with the opportunity to participate fully in schooling.

Education is the main way out of poverty and this pathway must remain open to every child.

President's Report

The last year has seen a continued increase in the demand for State Schools' Relief Services.

From a high of 38,000 students assisted in the 2015/2016 years, this year has seen over 58,000 students in government schools assisted with school uniforms and shoes. This assistance has contributed significantly to student wellbeing and school participation and is a major form of support for school costs for low income parents. The continued financial support of the Victorian Government has enabled SSR to perform this important and needed work.

The main programs that SSR delivers are our continued charitable program and the new Prep and Year 7 programs for children qualifying under the Camps, Sports and Excursion fund. The Prep and Year 7 programs have been enthusiastically embraced by schools and parents and make up half of our clothing support.

SSR's own label, Student Choice, has also enabled us to sell uniforms and shoes to schools at competitive rates and is developing as a major future source of income for SSR.

A major project that SSR has undertaken this year is the Glasses for Kids program. Funded by the Victorian Government this project will, by mid 2019, have provided testing, screening and dispensing services to children in 250 Victorian Schools. The project is being delivered as a partnership, involving the Department of Education & Training, Melbourne University, One Sight, Wide Open Road, Wodonga Eye Care and the Australian Education Union amongst others.

SSR has also funded a research project to be undertaken by Melbourne University to assess the qualitative benefits of the program. However, at this point of the project, there is much anecdotal evidence that points to the impact of the program on students' learning outcomes.

The huge increase in activity has meant that SSR has had to develop a sophisticated warehousing and logistics distribution centre at our Dandenong South headquarters and this could not have been achieved without the ongoing support of Toyota Australia.

It has also meant an increase in staff and the once small SSR has now separate finance, warehousing and operations areas, all of which come together to provide a seamless ordering and distribution service to all Victorian government schools.

The Board continues to focus on our core accountability to ensure that SSR remains a financially sustainable organisation delivering high quality service to schools eligible students and their parents.

Over the next year, a major task of the Board will be locking in funding for the period into the early 2020s and to more proactively pursue fundraising activities. Fundraising from schools, which once contributed to over 50% of our fundraising efforts has declined sharply over the past 2 years and SSR needs to examine and put in place new and different strategies to ensure sustainability in the level of support we currently provide.

Board sub committees are an important part of our monitoring, oversight and strategy development. Once again I thank committee conveners Rommie Redlich, Christine Stewart, Robyn Wilson and Maria Shearn for their work with the sub committees. I would also like to thank my fellow Board members for the work, effort and thought put into our governance. SSR has become a much more complex organisation and subsequently demands much more for its directors to ensure a successful organisation.

Thanks to Board members Kate Fenby and Leilani Landeryou who were both unable to continue their board duties this year. Kate made a great contribution in marketing and Leilani very ably represented the interests of parents.

The defining feature of SSR is the quality and commitment of its staff and it is the staff that

have enabled SSR to perform its work so well. Special thanks to our longest standing employee Val Marshall who after nearly 11 years' service retired recently. Val has made an outstanding contribution to the work of SSR and will be missed by both schools and SSR. On behalf of the Board I thank all staff members for their work in enabling disadvantaged state school students to participate in school.

Thank you to our sponsors large and small who give to our cause. Particular thanks to the Department of Education & Training, the Australian Schools Canteen Association, The Australian Education Union, Bank Australia and Victorian Teachers Mutual Bank for their support and commitment. We would not be able to do our work without them.

SSR is the sum of many parts working for a common objective, continuing that work is the key to continuing support for enabling disadvantaged students to have successful education pathways.

CEO Report

The injection of \$15.6 million from the Victorian Government in 2016 enabled SSR to boost its contribution to the educational needs of students significantly.

In 2015/2016, we supported over 38,000 students with uniform and school requirements and that number has increased to 58,000 in 2016/2017. Whilst the CSEF (Camps, Sports and Excursions Fund) has seen a huge increase in our work, one of the other excellent programs has been the Glasses for Kids programs. Our introduction to the Toyota warehousing strategy has delivered excellent outcomes in our streamlining process in all areas of production.

The promotion and introduction of our Student Choice products are travelling well and means increasing alleviation to the cost to schools and families for numerous key uniform requirements. So many great initiatives, supporters and a great team all combine to make SSR an invaluable organisation for Victorian schools and families.

We know that poverty is a key reason that impacts on the educational outcomes for our children. With continued assistance with uniform and some of the other essential items (e.g. Graphing Calculator and work boots), we can play a role in promoting pathways and success.

School Communities

School communities remain a much needed source of fundraising to support the efforts of SSR. There have been many and varied events over the past year throughout government schools in Victoria that have assisted SSR provide the ever-present need for assistance to disadvantaged students. Established by principals and teachers, SSR continues to be sustained by Victorian educators.

Staff and Volunteers

We have a dedicated team of staff and volunteers at SSR. Improving our systems, to ensure prompt service to schools, is a feature of our committed team in all facets of our operations. It is with sincere appreciation and thanks that I acknowledge the work of Val Marshall (Operations Manager) who recently retired but spent almost eleven years going above and beyond to see that schools were provided with personable and professional assistance.

A big thank you to our volunteers who form an integral component of our service and we have been most fortunate to have their assistance throughout the year.

Board

Thank you to our Board members who continue to provide excellent support and leadership, particularly through the work of the President, Barry Smith. His guidance in our performance-based business management model has ensured we continue to operate at a high standard.

Partners

SSR relies on a committed group of sponsors, many have been with us throughout and others are welcome new additions to our support base. I would like to thank all sponsors for their acknowledgement of the importance of SSR support to Victoria's most vulnerable families and students. To this end, I extend our thanks to the following in particular: The Victorian Government, the Department of Education and Training (DET), Victorian Principals' Association, The Victorian Association of Secondary Principals, the Australian Education Union, the Australian School's Canteen Association, the Victorian Teachers Mutual Bank and Bank Australia.

Challenges

The implementation of the CSEF saw a significant increase in SSR support to our Victorian government school communities. As with all new initiatives, there are challenges. We believe, in conjunction with DET, we have made considerable adjustment to the manner in which the CSEF uniform packages to eligible Prep and Year 7 students are rolled out. We aim to have the Year 7 packages for 2018 out to Secondary Schools by Orientation Day.

Aside from these students, there is always a need to address the requirements of the many students, who for one reason or another, require assistance to be school ready.

Participation in education is the main way out of poverty and this pathway must remain open to every child.



We've come such a long way in our history. Our archives from 1934 tell us just how far:



Food. Several hundred hot meals were provided daily. Primarily in the form of subsidies to philanthropic societies.



Clothing. 3,551 new garments and large quantities of good second hand clothing were supplied.



Footwear. 2,099 pairs sent to schools, some free, others at discounted prices.



Paper. Supplies were provided for some schools where students have a difficulty in obtaining writing material.



Puddings. 400 Christmas puddings were made and distributed.



Milk. At the request of the Sustenance Department, State Schools' Relief administered a grant for a daily supply of free milk for children requiring it. During the winter months approximately 8,500 children from 115 schools received a daily milk drink.



Finance. Receipts from all sources totalled \$1,207. Of this, \$385 was spent on clothing, \$536 on footwear and \$132 on food.

The Challenge

TACKLING INCREASED DEMAND

Historically, State Schools' Relief has fulfilled around 10,000 applications for shoes and uniforms each year. This financial year recorded a 20% increase in applications to 45,785.

This increase in assistance has been driven by the inclusion of eligibility-based assistance for Prep and Year 7 students who are eligible for the Camps, Sports and Excursion Fund. These students were automatically eligible for a subsidised uniform package.

Applications for financial assistance increased 20% compared to the previous financial year. This increase has been attributed to the discontinued Education Maintenance Allowance (EMA) in 2015. Previously 25% of families with children attending State Schools received the payment, previously, corresponding to around 160,000 children in 2015.

Additionally, the School Kid's bonus of \$422 for Primary School students and \$842 for Secondary students was discontinued in July 2016, consequently increasing applications.

The partial replacement of this payment is the Victorian State Government grant State Schools' Relief secured for \$15.6m over 4 years, representing a benefit of \$20 per child.

The average cost of each application to State Schools' Relief was \$120, down from \$142 last financial year.

FUTURE INCOME COMMITMENT:

This secured Victorian Government grant will have a transformative effect on the scale and impact of our efforts and will enable us to continue the much needed support of those families most disadvantaged in our state.

INCREASE PRODUCT RANGE:


The core business is to get children in the school gate, ensuring they have a school uniform and shoes. Building on this, we now offer an extended range of products to assist success in school:

EYE TESTING. A foundation partnership has been established with The University of Melbourne, OneSight (OPSM's charity partner) supported by the Victorian State Government as part of Education State. This partnership has enabled State Schools' Relief to engage with 250 schools to ensure students have access to glasses where required.

WORK BOOTS. VET in Schools students require work boots.

CALCULATORS. Graphing Calculators are utilised by Year 11 and 12 students. They are a significant cost to families of the student retailing over \$200.

STATIONERY. Thank you to Target and Bannockburn Primary School for donating stationery for Primary School students.



70% Primary Schools, 95% Secondary Schools & 92% P-12 utilised our services this financial year.

Our Response

REDUCING COSTS

DISTRIBUTING PHYSICAL ITEMS:

One successful method of decreasing the average cost per child has been by working closely with schools to provide our wholesale label uniforms and shoes where possible. High quality clothing is provided which closely resembles the branded items used by other students. State Schools' Relief has successfully fostered agreements with 45 state schools to substitute items in place of vouchers.

VOLUNTEERING AND IN KIND SUPPORT:

Deakin University

Student Saania Habeeb, who developed State Schools' Relief's Topsy Turvy campaign as part of The School of Communications & Creative Arts curriculum, has won an International Association of Business Gold Quill Award in the Student Category of Communication Management. This is a prestigious award that attracts a large number of entrants. Congratulations to Saania and thank you for your creativity with this campaign.

Toyota

Toyota's years of manufacturing experience have taught them that small improvements can make a big difference, so for more than a decade they've shared their approach to help other organisations. They believe sharing their ideas this way helps their partners stay competitive and preserve jobs and support more people in need and that benefits us all. State Schools' Relief has benefited greatly from Toyota's generosity.

Secondary School Students

Partnerships with Nossal High and Heathmont College have been established for students to

volunteer at State Schools' Relief as part of their curriculum. This partnership assisted students to understand the issues around disadvantage and how State Schools' Relief is assisting these students to remain in school. In return, State Schools' Relief establishes a strong relationship with the schools, and increases much needed volunteer labour.

Glasses for Kids

The provision of glasses through OPSM's charity division OneSight, has led to the creation of the Glasses for Kids program. The program helps to break down barriers of poverty for children from vulnerable families and supports participation in education from the early years.

State Schools' Relief has constructed a coalition to provide the program, which will provide vision screening, testing and dispensing of corrective glasses, where medically necessary, for all Prep to Grade 3 students in the 250 most disadvantaged Victorian government schools. The foundation coalition consists of The University of Melbourne, OneSight and The Victorian Government. The program will run until June 2019.

ENSURING ASSISTANCE IS RECEIVED BY DISADVANTAGED STUDENTS

DISTRIBUTING PHYSICAL ITEMS:

A consequential benefit of supplying physical items is that this ceases any possible parent co-payment and most importantly we know the students will receive the items. In many cases vouchers expire where the family or carer cannot afford the co-payment or unable to get to the retailer.

IMPLEMENTATION OF ELIGIBILITY-BASED PACKAGES:

Historically, applications for support have been made directly from the Schools where the child's family has a Health Care Card or where the school deems the student in need. In 2015, State Schools' Relief released its first eligibility-based packages. Any child enrolled in Prep or Year 7 who was also registered for the Camps, Sports and Excursion Fund was also eligible for State Schools' Relief package which included basic uniform items needed to start school. Starting a new school was identified as a key time in a student's life that carried significant financial costs. This package was created to greatly reduce these costs. There was a 27% increase in uptake in the Year 7 Package compared with last year to 11,848 package, and a 5% increase in update in the Prep Package to 6,083 (the Prep Package was released April 2017 and therefore this number continues to grow into the 17/18 financial year).



Capturing the voice of our stakeholders

From the Principal of a Gippsland school.

I thought I'd take this opportunity to drop you a line and share with you an experience you don't see every day.

Following this week's delivery of uniforms for the children, I took the opportunity to deliver the boxes as the family concerned are without transport at the moment. The whole affair has been a very sad one with the children wearing ill-fitting clothes, a lack of food in the house and a male guardian who has deserted the home and left them to fend for themselves. Of the four children in the family, three attend the Primary School and of these children two are disabled in some capacity.

When I arrived at the home the children had all been bathed and were reading books sitting on the couch. I carried the boxes of clothing into the lounge room and helped them distribute the parcels. The looks on the faces when they opened the packages were something to behold and the squeals of joy were quite moving.

This morning at school the children arrived wearing their new clothes and the looks on their faces said it all. They looked resplendent in new gear and as one boy approached me, I asked how he felt. He replied "It is good to be like the other kids."

It has been a wonderful, tangible way through which to provide immediate, high level support with instant impact. I must add that these children have received an immediate boost to their self-esteem thanks to the State Schools' Relief Committee Inc.

Thank you for your incredible support, I salute you all.
